

Needs Based Scholarship Information & Application Form

Introduction

Castlemaine Steiner School & Kindergarten offers a contemporary, holistic education, guided and inspired by the teachings of Rudolf Steiner and his observations of the developing child.

The Castlemaine Steiner School & Kindergarten (CSSK) seeks to foster an inclusive and diverse socioeconomic community and hopes to make Steiner education more available across our regional community.

CSSK is offering a number of partly or fully subsidised places to eligible applicants of new families to the school, who would otherwise not have the opportunity to enrol due to financial disadvantage. CSSK scholarships run year-round for Kindergarten to Class 7 and applications can be made at any time following a successful enrolment process.

The scholarship provides a subsidy of up to 100 percent of tuition fees for eligible students of new families to the school subject to the conditions set out below. In most cases, ancillary fees and charges such as camps and excursions will be the responsibility of parents/guardians.

Who is eligible to apply?

To be eligible for a CSSK merit-based scholarship, applicants must meet the following conditions:

- 1. Be an Australian citizen or permanent resident
- 2. Have successfully completed the enrolment process at CSSK as a new family entering the school.
- 3. Provide evidence of financial disadvantage. Generally, this will be met if the child is named as the card holder or a dependent child on a valid government concession card within the meaning of the State Concessions Act 2004, that is, on a:
 - Centrelink Health Care Card
 - Pensioner Concession Card
 - Veterans Affairs Gold Card
- 4. Demonstrated commitment to the principles of Steiner education and CSSK; this is also expected from parents / guardians of applicants.

Existing scholarship holders may submit a new application at the conclusion of their current scholarship period, where applicable.



How applications will be assessed?

Our aim is to maintain a balanced approach, ensuring the most effective use of our resources while upholding our commitment to educational excellence and social equity.

All applications will be assessed by the CSSK Scholarship panel, who will determine the final number of scholarships to be awarded by taking into consideration the below factors:

- The above stated eligibility conditions
- The quantity of applications across different year levels and the ability of the class and teachers to meet the students' educational needs

Once scholarship applications have been assessed applicants will be notified via email regardless of the outcome. Assessments are expected to be completed within four school weeks of a received application.

Scholarship Terms and Conditions

1. Application Requirements

- Families must formally apply for a scholarship via the CSSK Scholarship Application Form.
- Assessment of eligibility and any offer of a scholarship is made solely at the discretion of the CSSK Scholarships Panel.
- Scholarships may be awarded to students from Kindergarten to Class 7, depending on availability and panel recommendations.

2. Attendance Expectations

- Students must maintain a minimum school attendance rate of 80% throughout the scholarship period, unless there is an independent learning plan or absence is because of medically certified illness.
- Repeated, unexplained, or prolonged absences may result in a review of the student's eligibility for continued scholarship support.
- Parents/guardians must notify the school of any absences in accordance with school policies.

3. Behaviour and Conduct Requirements

- Scholarship holders are bound by the same rules, responsibilities, and rights as all other students at CSSK.
- Students must demonstrate consistent adherence to the school's Four Pillars of Expected Behaviour:
 - o Be respectful and polite
 - Be ready to learn, actively engage in learning and allow others to learn
 - Be safe and look after school property and resources
 - o Follow instructions given by school staff members
- Significant or repeated breaches of behaviour expectations may lead to a review or withdrawal of the scholarship.

4. Parent/Guardian Commitments

 Parents/guardians agree to support and uphold all CSSK policies, procedures, and behaviour expectations.



- Parents/guardians acknowledge and respect the authority of school leadership and agree to support decisions made by the leadership team.
- Actions that undermine school policies or leadership decisions may affect the continuation of the scholarship.

5. Ongoing Eligibility, Review, and Termination

- The school reserves the right to review scholarship status at any time if concerns arise regarding attendance, behaviour, or adherence to school expectations.
- A scholarship may be terminated by the school in the event of a serious breach of CSSK Policies or Codes of Conduct by the student or their parents/guardians, or if the family's account falls into default in accordance with the Fee Retrieval Policy.
- Scholarships may also be suspended or withdrawn if any other Terms and Conditions are not met.

6. Enrolment and Fee Liability Condition

- Continued eligibility for the scholarship is dependent on the student remaining enrolled until the completion of Term 3 each academic year throughout the duration of the scholarship.
- If a student withdraws, or their enrolment is otherwise terminated, prior to the commencement of Term 3 in any given year, the parent(s)/guardian(s) agree to be liable for one term's tuition fees.

7. Acknowledgment and Agreement

By accepting the scholarship, both the student and the parent/guardian acknowledge that they
have read, understood, and agree to comply with these Terms and Conditions.
